

Privacy policy

Our company, Chimimportexport Plurimex SRL headquartered at 26, Tunari Street, sector 2, Bucharest, Romania has committed itself to respecting the privacy of users of our site, www.chimimport.ro .

The policy of protecting individuals with regard to the processing of personal data is based on [the General Data Protection](#) (GDPR), which is effective as of 25th May 2018 and which creates consistent rules on the protection of personal data in the European Union, as well as on applicable national law.

This general policy applies to the www.chimimport.com website which you access, a website managed by Chimimportexport Plurimex SRL.

While you can access its content without providing any personal information, in some cases this information is required to be able to provide you with the online services you request, according to the stated purposes and in order to receive professional information.

Such information is processed in accordance with the provisions of the aforementioned regulation and we want to inform you on how they are used, as follows:

- **The collected data is physically hosted** on a web server located within the EU, under the administration of TELEKOM ROMANIA S.A. which meets the highest security standards accepted at industry level.
- **The collected information is stored in the TELEKOM ROMANIA S.A server.**
